OPEN GRANT CALL

DEADLINE FOR APPLICATIONS: 22 JANUARY 2023

The COST Action CA18232 “Mathematical models for interacting dynamics on networks” invites applications for STSM and conference grants (see the list below), for activities to be undertaken between **1 February 2023** and **31 October 2023**. Applications should be submitted via the e-COST platform by **22 January 2023**, a decision is expected to be reached by the end of January.

It is expected that there will be another call in the middle of the calendar year, albeit with a more limited budget. Any updates will be communicated via the usual channels including the Action website

Types of grants available.

- **Short-Term Scientific Mission (STSM) Grants:** typically offer up to € 2 000 towards research visits ranging from a few days to a few months between members of the Action, including doctoral students, to carry out research activities within the scope of the Action. Requests for higher amounts up to the limit allowed by COST will be considered but should be carefully justified.
- **Dissemination Conference Grants:** typically offer up to € 750 to help fund participation of Action members in high-level face-to-face conferences, to present work related to the Action to an outside audience. Requests for higher amounts will be considered but should be carefully justified. For online conferences up to € 500 can be paid to cover conference fees.
- **ITC Conference Grants:** work in the same way and with the same funding limits as Dissemination Conference Grants, but are only open to Young Researchers based in Inclusiveness Target Countries and Near Neighbour Countries.

Specific rules apply to each type of grant and in some cases there are eligibility restrictions; for more details on consult the COST website or contact the Grant Awarding Coordinator of the Action (see the links below). All applications will be evaluated on their scientific merit, the relevance of the proposal to the Action, and in accordance with the inclusiveness criteria outlined in the Memorandum of Understanding of the Action.

Important notes.

- In addition to the usual documentation required by COST, as part of your application you must **also** provide an itemised **estimate of your expenses** (e.g. travel and accommodation costs). This information should be included as a text or pdf file uploaded to e-COST with your application; alternatively, you may attach it to your CV or include it in the grant application form, if space permits. **Grant requests will not be considered unless this estimate has been received.**

- All grants will be managed via the e-COST system. To apply, you must have an account, go to

Your age and affiliation status will be determined automatically via the information provided in your profile.

- If you have not already done so, you should **apply for membership of one or more Action Working Groups** at

- In the event of a successful application, a lower amount may be awarded than was requested.
- You may apply for more than one grant of the same type; however, in general the total amount awarded in 2023 will not exceed the maximum amount which can be awarded for a single grant. For example, you may apply for a second STSM in a later call, but in the event of success the total amount awarded for the two missions will not exceed € 4 000.
- Many grants can only be paid after the event has taken place, and generally also require the submission of a report after the event, or other information, before payment can be made. Check before applying!
- For STSMs, after the activity has been concluded, along with the scientific report you must submit a brief **dissemination report**, a description of your STSM work and its impact/relevance/applications in non-technical terms, intended for a broader scientific public, suitable for publication on the Action's website. This report may be included in the same document as the scientific report. In general the STSM Grant will only be paid out after **both** reports have been submitted via e-COST and approved.
